Whereas, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council tor Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notifiod the Regulations, 2014 on 01.12.2014
2. And whereas, the Laxmi Bali Sahuji College, 747, Marhatal, Jabalpur - 482002, Madhya Pradesh by affidavit ot $10.01,2015$ has consented to come under new Regulations and sought for one basic unit in M.Ëd. which require additional facilities
3. And whereas, it has been decided to permit the institution to have one basic unit of 50 students subject to the institution fulfilling following conditions namely,
i. The institution shall identify/select the full component of the facultyistatt, as per NCTE Regulations, 2014, and approval of the affiliating body be obtained and the same may be conveyed to the Western Regional Committee in the prescribed manner and in the prescribed proforma, giving details of qualification and experience of the Faculty/Staff selected alcongwith the letter of approval of the affiliating body by that date.


#### Abstract

(1) The institution shall create additional fasihties that include (a) additional built-up area. (b) additional infrastructure, (c) additional funds, as per Regulations, 2014 and inform the Regional Committee with required documents such as certified copy of registered land documents. Certificate for Land Use (CLU), copy of approved Building Plan (BP) and Encumbrance Certificate (EC) in proof of having the additional tacilites, before May 30, 2016. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can be given to the Visiting team at the time of inspection.


iii. In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/Complaint etc, the institution shall be required to submit a copy of the Hon'ble Court orderireply to SCN/complaint/already submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institutions shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt and such offer documents as indicated in the revised format recognition order. The *ina decision shall be subject to the directions given by the Hon'ble Court in the Wort Petition/case decided by the Western Regional Committee in respect of Section 17icomplaint cases etc.
4. Now therefore in the light of the above and in accordance with the NCTE Requiations, 2014 the Western: Regional Commines (NCTE) hereby issues the revised recognition order to Laxmi Bi Sahuii College, 747, Marhatal, Jabalpur - 482002, Madhya Pradesh for conducting M. Ed programme of two years duration with an annual intake of 50 students (one basic unit) from the academic session 2016-17 subject to fulfillment of the conditions mentioned above

5 Further, the recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UCC affiliating University/Body, the State Government etc, as applicable. The affiliating body (University/State Govt.) shall also be required to verify the authenticity of the land $\&$ building documents as well as appointment of requisite teaching \& non-teaching staff as per provisions of the NCTE Regulations, 2014 by the concerned institution before grant of affiliation to an institution.

e) Fee charged from students;
f) Avaliable infrastruclural facilities;
gi Facilities addod during the last quarter;
hi) Number of books in the library, journals subscribed to and additions, if any, in the last quarter,
i) The affidavit wit? ondosure submitted atong wilh applization
i) The institution shall be free to post additional relevant information. if it so desires.
k) Any false or incomplete information on wobsite shall render the institution liable for wilhdraval of recognition.

If institut on contavenes anry of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the irstitution will rencer itself liable to adverse action includirg wilbdrawal of recognition by the Regional Committee under the provisiona of Section 17(1) of the NCTE Act 1993.
